- 2. Fees paid are not refundable.
- Under the GIRO scheme, official receipts for payment of school fees and miscellaneous fees will not be issued. Deduction will be reflected in the parent's/guardian's bank statement.
- 4. Parents/guardians are advised to ensure that sufficient funds are available in their accounts on the due dates. When the deduction by GIRO scheme is unsuccessful, the invoice for the outstanding amount will be sent to parents / guardians at their residential address and through email. An administrative charge of \$20 will be levied for any GIRO failure due to insufficient funds.
- 5. No Singaporean admitted to ACS (Independent) will be turned away because he/she is unable to afford school fees. Singapore citizens may apply for MOE Independent School Bursary (ISB) Scheme and/or School-based Financial Assistance Schemes. Please refer to the school's website for details.
