## Group 1: Studies in language and literature HL/SL

Language A: Language and Literature students will study a wide range of literary and non-literary texts in a variety of media. Students will investigate the nature of language itself and the ways in which it shapes and is influenced by identity and culture. The subject aims to enable students to:

- engage with a range of texts, in a variety of media and forms, from different periods, styles, and cultures
- develop skills in listening, speaking, reading, writing, viewing, presenting and performing
- develop skills in interpretation, analysis and evaluation
- develop sensitivity to the formal and aesthetic qualities of texts and an appreciation of how

they contribute to diverse responses and open up multiple meanings

- develop an understanding of relationships between texts and a variety of perspectives, cultural contexts, and local and global issues and an appreciation of how they contribute to diverse responses and open up multiple meanings
- develop an understanding of the relationships between studies in language and literature and other disciplines
- communicate and collaborate in a confident and creative way
- foster a lifelong interest in and enjoyment of language and literature

## Course Content

Across the three areas of exploration at least **four literary works** must be studied in the SL course and at least **six literary works** must be studied in the HL course. SL students are required to study **four non-literary texts** (bodies of work) equivalent in teaching and learning time, whereas HL students are required to study **six** 

**non-literary texts** equivalent in teaching and learning time. These nonliterary works might include: cartoons, advertisements, photographs, street art, music videos, speeches, films.

Internal assessment		
This component consists of an individual oral which is internally assessed by the teacher and externally moderated by the IB at the end of the course.	40 marks	30%
Individual oral (15 minutes)		
Supported by an extract from one non-literary text and one from a literary work, students will offer a prepared response of 10 minutes, followed by 5 minutes of questions by the teacher.
